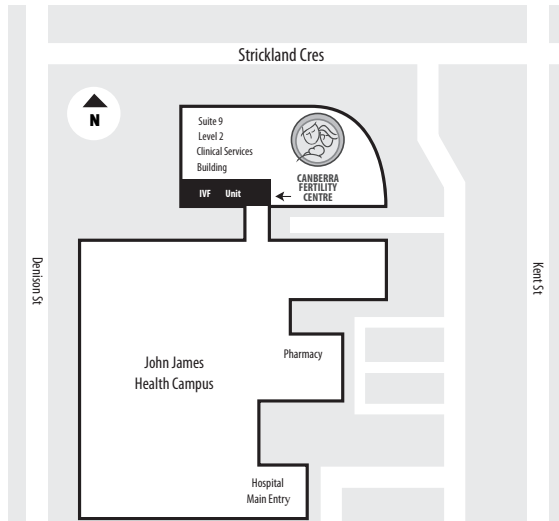

# Explanation of Fees

## Section 1

- > **Tracking**
- > **Ovulation Induction**
- > **Early Pregnancy Monitoring**

### **Blood Hormone Monitoring Tests**

Blood testing performed by the Canberra Fertility Centre for the above cycles is bulkbilled for all Medicare eligible patients. You will be asked to complete and sign a Medicare Assignment form for each test performed.

### **Follicle Watch Ultrasounds**

Follicle watch ultrasound tests performed by the Canberra Fertility Centre are performed at no charge for patients of the Canberra Fertility Centre. Patients referred from other clinics may receive an account from that clinic.

### **Pregnancy Ultrasounds**

Pregnancy ultrasounds (7–8 weeks) are performed at the Canberra Fertility Centre. The fee is \$80.00 Medicare Item Number is 55703 and the rebate is \$33.25.

### **Medications**

If medications are needed for the above cycles your doctor will provide instructions and a script to be filled at a pharmacy. Progesterone pessaries (200mg each) and Crinone 8% (90mg) may be purchased from the Canberra Fertility Centre with written authorisation from your doctor. Please contact the Canberra Fertility Centre for pricing of these two medications.

The Canberra Fertility Centre also sells ELEVIT, a Vitamin and Mineral supplement for pregnant and lactating women. This product is also beneficial when trying for pregnancy as it has the necessary folic acid and iron content.

MENEVIT is also available and is specifically formulated for men.

### Introduction

Despite Medicare funding, all Assisted Reproductive Technology Services such as Insemination (AIH/AID), IVF and FET procedures still bear out-of-pocket or gap expenses for the patient. Complex treatments such as these involve the services of many different health professionals. These professionals will bill separately for their respective services so you may receive accounts from the following sources:

- a) Your Gynaecologist/ Canberra Fertility Centre
- b) Your Anaesthetist
- c) CAPS Clinic

An individual patient's account is dependent upon the actual treatment received, whether any complications arise during treatment and the level of cover from the patient's particular health fund. The exact nature of the account will depend on the procedure undertaken, the amount of medications used and the length of stay in hospital.

The Medicare rebate for Insemination (AIH/AID), IVF, IVF/ICSI and FET procedures is provided under global item numbers 13203/13200/13201/13218. These global item numbers cover the laboratory-based aspects of the treatment. The fee associated with these items applies irrespective of the outcome of the treatment procedure, including whether insemination, fertilisation or embryo transfer occurs, or whether 1 test (blood test or ultrasound) or many tests were performed during the treatment.

The estimated out-of-pocket expenses in this handout only apply if Medicare covers you. If you are not covered by Medicare please consult the staff at Canberra Fertility Centre who will give you another handout outlining your expenses.

## Doctor Referrals

To receive the Medicare component of your invoice, you must have a current referral to your Specialist from your General Practitioner (GP) valid for 12 months or a referral from a different Specialist valid for 3 months. Please ensure your referral does not expire during your cycle. If your **referral is out of date** at commencement of your cycle you **will not be eligible** for any Medicare funding. It is your responsibility to maintain a current referral.

## Safety Net

Medicare runs a Safety Net program for all Australian residents. This means, once your out-of-pocket, out-of-hospital medical expenses exceed the Safety Net threshold in a calendar year, you will be rebated a portion of those expenses by Medicare. The Safety Net threshold is indexed to the CPI and is \$1157.50 at 1 January 2011.

This program was recently overhauled by the government and all item numbers relating to Assisted Reproductive Technology have been capped. This means a maximum amount of money (referred to as the cap) will be rebated to you per cycle and this amount may vary with subsequent similar cycles in the same calendar year.

Please contact Medicare on 132 011 for further details or consult the Health Insurance Commission website [www.hic.gov.au](http://www.hic.gov.au) and follow the links to Medicare Plus. Medicare requires proof of payment for all out-of-pocket expenses before they can process safety net claims. **Please retain copies of all accounts and receipts you receive from Canberra Fertility Centre.**

## Pre-Payment

A pre-payment system operates whereby the basic out-of-pocket cost of the procedure/cycle is paid before treatment commences. Please pay the amount indicated in Table 1 to the Canberra Fertility Centre before your cycle starts. The balance of the account is rendered at the completion of treatment and will include the cost of any extra services used. This account is due within 30 days of that time. Please refer to the section on Cancelled Procedures for details when the treatment is cancelled.

## Fees from Gynaecologist/Canberra Fertility Centre

Please be aware the gap expense on your account may differ depending on the extent of extra services used as outlined in Other Expenses or the level of safety net rebate you are eligible for. Please contact Medicare on 132 011 to determine your level of eligibility.

## Payment of Accounts

You will receive an account from the Canberra Fertility Centre that includes the services provided by your gynaecologist during your treatment. The pre-payment amount will have been deducted, and the balance owing will be shown. This account is due within 30 days. Please forward the account with the accompanying Medicare claim form to Medicare Assessing and Benefits GPO Box 9822 Sydney NSW 2001. If you submit the claim to your local branch the claim is forward to the above address for processing. The Medicare rebate cheque **plus** any outstanding amount will then need to be paid to the Canberra Fertility Centre to finalise your account. Medicare will notify you in writing regarding your safety net rebate and forward a refund, once they receive confirmation of payment of all accounts (usually a receipt of payment).

## **Other Expenses**

### **a)      **Lucrin/Synarel /Progesterone Pessaries/Crinone****

These drugs are often required for IVF treatments. Lucrin or Synarel to oocyte collection and Progesterone Pessaries or Crinone to 12 days post oocyte retrieval (Day +12) are all included in the cost of Item 13200.

### **Cetrotide/Orgalutran**

These medications are paid for at the time of collection

### **Progesterone Pessaries/Crinone**

These items can be purchased separately. Progesterone Pessaries 200mg supplied in bottles of 15 @ \$85.00 and Crinone gel @ \$12.50 each. If pregnancy occurs, Progesterone Pessaries or Crinone may be required to be used up until the end of the first trimester.

### **b)      **Embryo freezing – Payment due on day of transfer****

If you obtain extra embryos and you have elected to have them stored the fee is \$750.00. This includes the cost of initial freezing and storage for 12 months. If you wish to continue storage thereafter, there will be an annual fee of \$250.00 for which you will receive an account. This is also outlined in the “Cryopreservation and Storage of Embryos” consent form. This initial storage fee will be included in Item 13200/13201 in the final account. Payment of this fee at the time of embryo transfer is recommended to expedite your claim from Medicare and your Safety Net rebate.

### **c)      **Oocyte Freezing – Payment due at time of freezing****

If you obtain oocytes and you have elected to have them stored the fee is \$750.00. This includes the cost of initial freezing and storage for 12 months. If you wish to continue storage thereafter, there will be an annual fee of \$250.00 for which you will receive an account. This is also outlined in the “Cryopreservation and Storage of Oocytes” consent form. This initial storage fee will be included in Item 13200/13201 in the final account. Payment of this fee will be due at the time of initial freezing, which is recommended to expedite your claim from Medicare and your Safety Net rebate.

### **d)      **ICSI (Intracytoplasmic Sperm Injection)****

If ICSI technique is to be used the fee associated is \$522.50. This fee forms part of the prepayment for the procedure. This fee is refunded if the technique is not used.

**e) Blastocyst Culture**

If blastocyst culture is to be used a separate fee does not apply.

**f) Donor semen**

If donor semen is needed in your treatment the cost per straw is paid upon reservation of that straw. Donor semen sourced from other fertility clinics or overseas will vary in price. This will be discussed with you at the time of selection/reservation.

**g) Assisted Hatching**

If you have elected to use Assisted Hatching a separate fee does not apply.

**h) Semen freezing – Payment due on the day**

If your partner is going to be unavailable during the treatment or he needs to store semen for other reasons (illness) then the cost of freezing and storage of a sperm sample is \$750.00. This includes the cost of initial freezing and storage for 12 months. If you wish to continue storage thereafter, there will be an annual fee of \$250.00 for which you will receive an account. This is also outlined in the "Cryopreservation and Storage of Semen" consent form. Payment for this service is required at the time the sample is provided.

**i) MESA/TESE Collection**

If a surgical method is required for collection of a sperm sample at the time of oocyte retrieval then a fee of \$100.00 will apply. This does not include the medical or hospital fees that may apply for this procedure. Please contact your Urologist for full details. If semen is to be stored, then the freezing and storage charges will apply (see g above). This fee will be included in the final account.

**j) PESA Collection**

If a fine needle aspiration is required for collection of a sperm sample then a fee of \$600.00 will apply. This procedure is carried out at the Canberra Fertility Centre.

If this procedure is carried out at another facility then a fee of \$100.00 will apply for our attendance. This does not include the medical or hospital fees that may apply for this procedure. Please contact your Urologist/Surgeon for full details.

A Medicare rebate is available for the PESA procedure and the Item Number is 37605 and the 85% rebate is \$305.45. If semen is to be stored, then the freezing and storage charges will apply (see h above).

## **Anaesthetist – Invoice will be mailed to you**

Anaesthetic services are necessary for IVF and ICSI procedures and may be used in other procedures. The fees charged range from \$400 – \$600 and the Medicare rebate may vary, please ask the coordinating sister to find out who your anaesthetist is likely to be. If you have private health cover you may be eligible for a further rebate. Contact your fund to clarify your position.

## **Caps Clinic – Payment due on the day**

IVF, and ICSI oocyte (egg) collection procedures, performed at the Caps Clinic will incur a fee. This fee will vary depending on whether you, the patient, have no insurance or private health insurance.

For those patients who have no insurance, the out-of-pocket cost to be paid on the day of the procedure is approximately \$1,100.00 plus the cost of the anaesthetist (as above).

For those patients who have private health insurance, the Caps Clinic will inform you on the day of the procedure what your payment will be. It will vary depending on your health fund and level of cover. Please contact the Caps Clinic (02 6282 1155) or your health fund for further information.

## **Cancelled Procedures**

For a cancelled Insemination (AIH/AID), IVF, IVF/ICSI and FET procedure any prepayment that has been made remains intact and you can use this in future treatments or request a refund (proof of identity required). Canberra Fertility Centre will bulk bill Medicare for your cancelled cycle and you will not incur any costs.

## Section 3

### Testing performed outside Canberra Fertility Centre

In some instances blood tests and/or ultrasound scans need to be performed by outside providers. This will most likely be the case if you live outside the ACT. Outside service providers often charge higher prices than those charged by the Canberra Fertility Centre. If you are having ovulation tracking or other procedures not involving a global item number then you are responsible for the full charge. If your procedure is covered by a global item number (IVF/FET/Insemination) then the Canberra Fertility Centre will pay a proportion of the fee and you are responsible for any balance. The proportion paid by the Canberra Fertility Centre is the equivalent cost a patient would have incurred by having such tests performed at the Canberra Fertility Centre. The contribution made by the Canberra Fertility Centre is shown in Table 1.
